### **AGREEMENT**

THIS AGREEMENT made in duplicate

WITNESSETH THAT Crossroad Farms Ltd. is the owner of the land as follows: Lots 6 to 20 block 1 Plan 102203064

### IT IS AGREED THAT:

- 1. That the municipal tax of said combined, undeveloped property listed above, owned by Crossroad Farms Ltd., shall be at the base rate of \$ 1,000.00 per year for the years 2023 to 2027 inclusive. If any of the said lots are sold or developed they shall be taxed at the standard tax rate.
